

### Voting Instructions

#### ★ Are You Eligible?

To vote in this election, you must currently reside, produce and sell corn in one of the affected districts. If you do not meet this qualification, please discard the ballot. Individuals, partnerships, corporations or other business entities are entitled to one vote. Combinations of persons sharing in gross receipts from the production and sale of corn in Wisconsin are entitled to one vote only.

#### ★ How Do You Vote?

The election this year is for one candidate from each District: Districts 3, 5 and 6. As an alternative to the candidate(s) on the ballot, you may write in the name, address, and city of a producer from your district.

- Indicate your vote with an "x" (located to the left).
- Sign the certificate statement (located on the reverse side).
- Place the ballot into the postage paid return envelope and mail, postmarked by January 17th, 2015.
- Ballots may also be scanned and returned to Stacie.Ashby@wi.gov

Your vote is only valid if the signed certification statement is signed and included. To preserve the secrecy of your vote, the ballots and certification statements will be separated prior to counting the votes. Please remember to sign and return the certification statement with the completed ballot.

*Your return envelope must be postmarked on or before January 17th, 2015. After receiving your ballot and before tabulating ballots, we inspect postmark dates and certification signatures.*

#### ★ Why Should You Vote?

This election allows you to elect a representative to the Wisconsin Corn Promotion Board. The board is responsible for the administration of Wisconsin's corn marketing order. The marketing order assesses each corn producer .05 cents per bushel on all corn grown in this state and sold into commercial channels.
